**\$0.4750 per share on January 30, 2020;**

**\$0.4750 per share on April 30, 2020;**

**\$0.4750 per share on July 30, 2020; and**

**\$0.4750 per share on October 30, 2020.**

15 Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ▶ **B&G Foods has determined that of such distributions described above, 74.95153% (or \$1.42408 per share will be treated as a taxable dividend and 25.04847% (or \$0.47592 per share) will be treated as a return of capital under Section 301(c)(2). Generally, the portion of the distribution on the common stock that is treated as a return of capital should reduce the tax basis in the shares of common stock up to a holder's adjusted basis in the common stock, with any excess treated as capital gains pursuant to Section 301(c)(3).**
